






Figure 2: X-NUCLEO-IDB05A2 circuit schematic - STM32 Nucleo connections

Figure 3: X-NUCLEO-IDB05A2 circuit schematic - BlueNRG-M0A module





Figure 4: X-NUCLEO-IDB05A2 circuit schematic - EEPROM
